### MODULE AIMS

The central aim of this module is to critically analyse the purpose, process and principles of the substantive law of the EU as it affects business within the EU. The main areas covered will be the free movement of goods, free movement of persons (especially workers and job-seekers and their families), freedom of establishment, dispute resolution mechanisms and an overview of EU worker's rights. Students will also be expected to develop a good understanding of: the legal position of non-EU nationals / businesses within the EU Single Market and the impact of EU Single Market developments on (people and businesses in) non-EU countries.

### MODULE CONTENT

#### Indicative syllabus content:

1. Introduction to EU Business Law: Critical overview of the key purpose, processes and principles of law of the EU Single Market.
2. Free Movement of Goods 1: Law and policy of harmonization in EU law.
3. Free Movement of Goods 2: Removing fiscal barriers to trade in goods (Customs Union (Article 30 TFEU) and taxation and the EU Single Market (Articles 110-113 TFEU)).
4. Free Movement of Goods 3: Removing non-fiscal barriers to trade in goods (Articles 34-36 TFEU).
5. Free Movement of Persons 1: Economically active persons and their families (Article 45 TFEU).
6. Free Movement of Persons 2: Citizenship and non-discrimination (Articles 18 & 20 TFEU).
7. Free Movement of Persons 3: Legal status, rights and obligations of third country nationals / businesses within the EU Single Market
8. Freedom to Provide Services (Articles 56-62 TFEU) and Freedom of Establishment (Articles 49-55 TFEU).
9. Resolving Legal Disputes in the EU Single Market 1: Against national authorities (SOLVIT, infringement proceedings, national litigation)
10. Resolving Legal Disputes in the EU Single Market 2: Against EU institutions / bodies (judicial review actions – Articles 263 & 267 TFEU).

This module is organised into 2-hour weekly seminars. During each seminar, the tutor will deliver a short presentation and facilitate a discussion of critical issues within the said topic led by the students, either working in groups or individually. Some topics may be divided between two Seminars. Students will be expected to have independently researched the issues for discussion in each seminar and to come to seminars prepared to respond and participate in an open and active critical discussion.
