Dr. Katerina Kalaitzaki is a Lecturer in EU Business Law at the University of Central Lancashire (Cyprus) since September 2021, where she has teaching duties both on the LLM and the LLB programmes in the areas of European Union Law, constitutional law, legal theory, and skills. Katerina holds a PhD in Law from the University of Central Lancashire, an LLM in European Law from the University of Nottingham and an LLB (Hons) from the University of Leicester, UK. She was awarded her PhD for her thesis "EU citizenship as a means of reinforcement of EU fundamental rights: challenges, developments, limits" in June 2019, after submitting it in December 2018. Katerina previously held an academic position in EU Law at the University of Edinburgh (2019-2021) where she acted as the Programme Director for the European Law LLM programme (2019-2020), Course Organiser for LLM and LLB courses and conducted research. Katerina is also an accredited mediator in Civil and Commercial Matters since April 2019 and a non-practising lawyer (Cyprus Legal Board) since September 2015. Katerina's research interests lie in the area of EU citizenship and EU fundamental principles and values. Current projects deal with the development and/or potential use of these concepts, including the rule of law principle, during periods of crises such as Brexit, Covid-19 and the rule of law crisis.
